

## TOP MATTERS

- Acting as junior counsel for the applicants in an action under sections 20 and 39 of the International Arbitration Act 2008 challenging the sole arbitrator's ruling that she did not have jurisdiction. The Applicants has so far successfully obtained a ruling in their favour on a preliminary jurisdictional point: *Digame Investment Company Limited & Ors v Apex Fund and Corporate Services (Mauritius) Ltd 2023 SCJ 273*.
- Acting as junior counsel for the Garnishees (Mauritian companies) in an attachment proceeding and injunction application whereby the Applicant seeks to enforce two partial awards in the sum of US 66,670, 553.76 and GBP 95,161.92 against the Respondent, a foreign company.
- Acting as junior counsel for the Respondents in an arbitration before the Mauritius International Arbitration Centre in a high value claim of USD 5.5 million in relation to a share purchase agreement.
- Acted as junior counsel in an international arbitration for the Respondent, a developer and/or promoter of a high value real estate project in Mauritius against a claim under a broker agreement.
- Acted as junior counsel for the applicant, a company incorporated in Mauritius for the purpose of investing and developing agricultural projects in Nigeria, seeking an interlocutory Mareva order under section 23 of the International Arbitration 2008.
