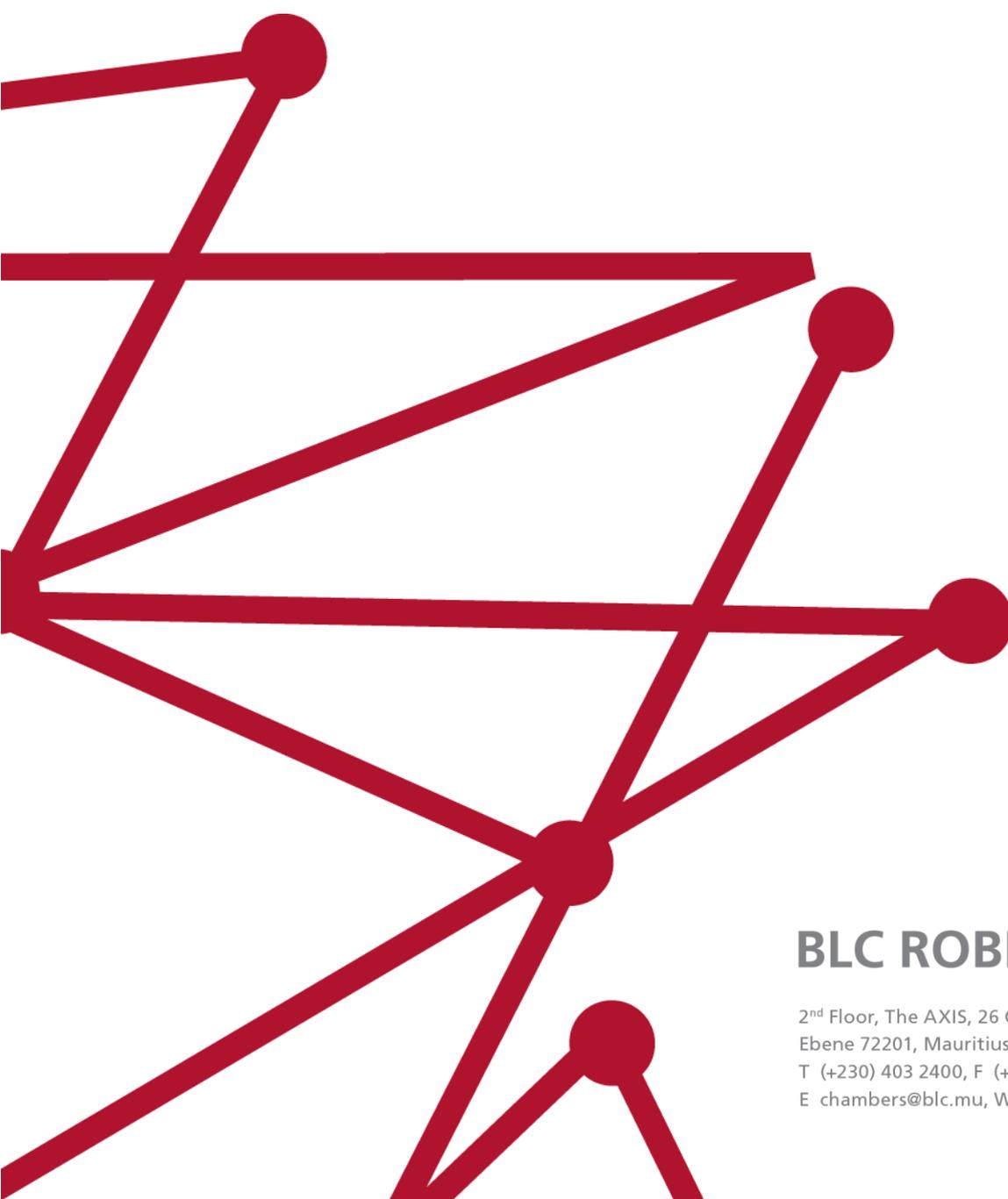

### **BACKGROUND**
